 - 3. The West Bengal State Book Board reserves the right to reject any or all quotation(s) without assigning any reason thereof.
- 4. The sealed quotations, recovered on the date fixed above, will be opened by the TENDER COMMITTEE after 2.00 P.M. of 11th March, 2019 (Monday). The intending tenderers, if they desire, may remain present at the time of opening of quotations.

5. The Terms and conditions of the contract will be as follows:

I. All pages of the tender documents should be signed with stamp by the authorized signatory of the Firm/Agency as a token of acceptance of all terms and conditions mentioned in the tender documents.

II. Specification of the steel gate:

- a. Total area of work 9'X 9"height and 5'X11" width.
- b. Upper Portion should be fixed (2'X 9" height and 5'X11" width by one inch steel angle with steel square bar and three inch gapping.
- c. Steel gate should be in two parts with one inch steel angle and Steel Square bar three inch gapping. Total size of gate is 7 feet height and 5'X11" width.

Fitting will be at Salt Lake office, 3rd floor (AQ 13/1 Salt Lake, Sector – V, Kolkata – 700091) of West Bengal State Book Board Building.

- III. Evaluation of tender for deciding L1 bidder shall be done on the basis of lowest rate quoted.
