Fresh sealed rate quotations are invited from the Firm/Agency who are the suppliers of the aforesaid Split AC including installation, testing and commissioning of air cold type at West Bengal State Book Board of AQ-13/1, Salt Lake, Sector-V, Kolkata 700091. The measurement of the 4th floor carpet area approximate sq.ft. We have required 4 (four) nos. of Cassette type split AC each capacity of 2.0 TR and 3 (three) nos. of Cassette type of split AC each capacity of 3.0 TR and 1 (one) no. of Cassette type split AC each capacity of 1.5 TR. The representatives of the Firm/Agency shall visit for inspection the installation area before the closing date of the said tender in between office working hours from Monday to Friday in the week.
