- 4. The sealed quotations, received on the date fixed above, will be opened by the TENDER COMMITTEE after 2.00 P.M. of 24<sup>th</sup> December 2018 (Monday). The intending Quotationers/Tenderers his representative, if they desire, may remain present at the time of opening of quotations.

## 5. The terms and conditions of the contract will be as follows:
